SUBJECT: Brake Pad Replacement On 2002 model year 440 PRO-X Fan and PRO-X 600 models, and 2003 model year pilot build 600 PRO-X and 440 PRO-X Fan models.

PURPOSE: Polaris Industries Inc. has determined that all model year 2002 440 PRO-X Fan and 600 PRO X model snowmobiles, and 2003 pilot build 440 PRO-X Fan and 600 PRO-X model snowmobiles may, under certain circumstances, incur a loss of braking due to brake pad material failure. Brake failure could cause a loss of control and possible severe personal injury or death. To ensure safety, Polaris is conducting a Product Recall campaign to replace the brake pads on all affected Polaris snowmobiles. This Recall Alert has been reported to the U.S. Consumer Product Safety Commission who will be monitoring this recall for effectiveness.

REPAIR PROCEDURE: Remove original brake pads and replace with PN 2202202. Refer to snowmobile High Performance Service Manual (PN 9917368) for replacement procedure. All brake pads (PN 2202203), discs (PN 1910523) and Caliper Kits (PN 2202197 and PN 2202199) currently in your inventory must be removed from dealer stock immediately. File a <u>Parts Stock warranty claim</u> for affected parts in your inventory and return them using the Warranty Parts Return label. Be sure to include a copy of the warranty claim. Caliper kit PN 2202197 is superceded by PN 2202391 and Caliper kit PN 2202199 is superceded by 2202390.

What is the reason for this notice?

Polaris has determined that model year 2002 440 PRO-X Fan, 440 PRO-X Liquid Racer, 440 PRO-X Rolling Chassis and 600 PRO-X model Snowmobiles may experience a loss of braking power during snowcross type conditions. This can result in bodily injury if not addressed. DO NOT OPERATE UNIT UNTIL ALL REPAIRS HAVE BEEN PERFORMED. This Recall Alert has been reported to the Consumer Product Safety Commission who will be monitoring this recall for effectiveness.

What should you do?

Please contact your Polaris Snowmobile dealer to make arrangements to have new brake pads (and brake disc on 440 PRO-X Liquid Racer and 440 Rolling Chassis) installed as soon as possible for correction of the brake system. Your Polaris dealer has received Safety Service Bulletins, S-02-03 and S-02-04 that describe the necessary repair procedure. *This repair will be performed at no charge to you*.

We encourage you to take your 2002 PRO-X Snowmobile into your Authorized Polaris Snowmobile dealer immediately to prevent any injury. DO NOT OPERATE UNIT UNTIL ALL REPAIRS HAVE BEEN PERFORMED.
