PURPOSE: The problem encountered with the Polaris Vertical Escape snowmobile involves the steering post. Specifically, the collar welded to the steering post can sometimes result in a weakening of the steering post due to an undercut condition at the weld toe, resulting in a thinner steering post wall section. If the condition is severe enough and occurs over a sufficient portion of the circumference of the steering post, the steering post can fail. This condition can result in the steering post separating and the handlebars and adjacent portion of the steering post becoming separated from the sled.

REPAIR PROCEDURE:

Remove steering post **PN 1821251-067** and replace with replacement post kit **PN 2202604**. Follow the instructions included in the kit.

CUSTOMER NOTIFICATION:

Notify customers to stop riding their 2003 800 RMK Verti-

<u>cal Escape immediately!</u> A customer notification letter will be sent to all registered owners of affected units. A copy of the letter is included on page 3 of this bulletin. In addition to the notification letter sent by Polaris, dealers are required to notify owners of delivered units and make arrangements to perform this warranty repair.

In cooperation with the U.S. Consumer Product Safety Commission, Polaris Industries Inc. is conducting a voluntary safety recall of all 2003 800 RMK Vertical Escape snowmobiles. Our records indicate that you are the current owner of a potentially affected snowmobile.

This letter is to notify you that Polaris Industries Inc. has determined that some of the steering posts on the Vertical Escape model may have a defect in the weld in the area of the top washer guide. This defect can result in breakage and separation of the handlebar from the steering post. If this separation occurs a loss of steering control may occur. This could cause the driver to lose control of the snowmobile and crash, possibly resulting in injury or death.

DO NOT OPERATE YOUR SNOWMOBILE UNTIL ALL REPAIRS HAVE BEEN COMPLETED!

Please contact an authorized Polaris snowmobile dealer immediately to arrange to have the steering post replaced. Authorized Polaris dealers have been issued a Safety Alert Bulletin, S-03-07, that describes the required replacement and repair procedures. The dealer will replace the steering post. This work will be performed at no charge to you.
